The rink went over budget about \$570 last year due to large snowfalls and the snow blower purchase and a longer season, so we have recaptured that this year.
- I met with a city representative for the Defibrillator program recently who checked the machine over and indicated that we need to do this check ourselves every few months and record it on the sheet of paper inside the cabinet door.
- I also met with the roofer who was asked to look at the GB lodge's roof by Parks.
